



## Welcome to the University of Arkansas 2017 DESIGN CAMP Student Expectations & Guidelines

*The University of Arkansas Design Camp aims to provide a safe, positive learning and living environment for all students and staff. Achievement of this goal depends largely upon the students and staff establishing an understanding of the guidelines and expectations of the program, which will help parent/guardians and students to understand student responsibilities, goals, expectations, rules, academic regulations, and other important program information.*

### **Student Participation & Responsibilities**

Students are responsible for understanding all the information contained in the Student Expectations and Guidelines. Once these guidelines have been discussed and signed, students will be held accountable for understanding and abiding by them. Students must attend and fully participate in all project-based activities, including field trips, tours and educational presentations. It is each individual's responsibility to make the most of all the educational opportunities provided through Design Camp. Students who choose not to follow these guidelines will face consequences that may include permanent suspension from the program.

### **Attendance Policy**

Students are required to attend all planned activities. Except in the case of an emergency, requests for absences must be made 24 hours in advance.

### **Transportation**

Students must provide their own transportation to and from Design Camp. Students with a valid driver's license will be allowed to drive their own automobile to Design Camp with parental/guardian authorization for students under 18. Parents/guardians must complete and sign the **Personal Automobile Authorization** form to authorize their child to drive. Parking information and a map will be provided. Students who are authorized to bring an automobile to the program are required to purchase a University weeklong parking permit. The University of Arkansas is not responsible for students' vehicles or personal property. A vehicle registration form will be provided upon request and must be completed and taken to the Administrative Services Building on Razorback Road to purchase a permit. Students will be required to show a valid driver's license to obtain a summer permit.

### **Academic Field Trips**

Students are expected to attend all scheduled field trips. Students will be notified in advance of any special attire that is required.

### **Illness/Accidents - Consent to Emergency Care**

Students and parents/guardians (for those under 18) are required to complete the "Emergency Medical Treatment Authorization" form, which was in the registration packet. This document will allow Design Camp staff to authorize medical care for a student in case of an emergency. **Design Camp insurance does NOT cover pre-existing illness or injuries or emergency room visits that are not accident-related. Design Camp will arrange for accident and injury insurance coverage for all participants, but the program insurance coverage applies only to injuries resulting from accidents occurring during programming. It will not cover emergency room visits that are not accident-related.** All medical bills related to illness or other issues are the responsibility of the student and/or parent/guardian.

### **Student Illness/Injuries**

Students should report illness and/or injuries to Design Camp staff immediately. If a student requests to be excused from daily activities due to illness, he/she must contact the program director or the assigned overnight counselor to discuss the situation.

## **Drug/Alcohol Policy**

Possessing or being under the influence of ANY non-prescription drugs or alcohol or abuse of prescription drugs while at Design Camp is unacceptable and grounds for termination from the program. Suspicion alone can result in suspension from the program.

## **Academic Guidelines**

Students are expected to:

- Be courteous and display respectful behavior toward faculty, staff, instructors, and other students.
- Attend all activities.
- Be on time.
- Be prepared.
- Display respectful behavior toward other students in classes in the building. (Running, talking loudly, or being disruptive while in the hall or workshops is not acceptable.)
- Assist in keeping the studios clean. Deposit trash upon exiting.
- Dress appropriately.

## **Parent Information**

Your student will be very busy throughout the summer program. If there are any problems, you will be notified. If you are eager to speak to your student, arrange a time for him/her to receive your call or call you. If you have trouble reaching your student by phone, please call **Theresa Parrish at 773-322-7164**. Cell phone numbers for overnight counselors will be available at move-in.

## **The Following Information Pertains to Residential Campers Only:**

### **Time Commitment**

The program consists of a one-week residential component. Students are expected to attend the entire program. Students will move in to the assigned residence hall (Humphreys Hall) between 2 p.m. and 4 p.m. on Sunday, June 11, and they will move out by 6 p.m. on Friday, June 16.

### **Roommate Assignments**

Each student can expect to have one roommate during Design Camp. Roommates will be selected based on the roommate assessment information received with the original application.

### **Learning to Live with a Roommate**

Living with another person can be a fun and enjoyable growth experience, as well as a challenge. An important part of a student's summer program experience is learning how to live effectively with a roommate. Learning this skill will prepare students for having a healthy relationship with a roommate when they go to college. The roommate agreement is an opportunity for the students to be proactive in establishing effective communication with their roommate. Every effort will be made to accommodate students. Boundaries should be set regarding use of one another's personal property and expectations of personal respect. Staff members will be available at all times to assist students with any roommate conflict. Students are expected to practice personal hygiene and maintain a basic standard of room cleanliness while participating in the summer program.

### **Privacy/Room Inspections**

The University reserves the right to enter a student's room, whether the student is absent or present, for the purpose of maintenance repairs or inspection for health and safety reasons. To ensure the safety and welfare of students, as well as to facilitate the smooth operation of the program, the residential staff may conduct periodic room inspections.

### **Damage to Room/Maintenance Needs**

Residence hall furniture is the property of the University and must not be abused or removed from the room to which it is assigned. **Damage or destruction of University residential property will be charged to the student responsible.** Each student is held responsible for any damage to his/her room. Normal wear and tear is not considered damage, but any such deterioration should be reported immediately to the overnight counselor for repair. Students may not deface the wall or doors of the residence hall. Pictures, posters, or other wall decorations may not be nailed or placed by any other means that will deface the walls. Students should not use nails, tacks, or screws on the walls or woodwork.

### **Telephone Use**

Residence hall rooms at the University of Arkansas are no longer equipped with telephones. Students are permitted to bring personal cell phones, which should remain on silent mode and be used only during free time. You may be asked to leave your phone in the residence hall during academic activities or field trips.

### **Lost/Stolen Items**

Students are responsible for the safety and security of their personal belongings. Design Camp is not responsible for any theft that occurs during the summer program. Students are encouraged to keep their room doors locked when they are not present. If an item has been stolen, contact the overnight counselor immediately, and he/she will contact the University Police Department. Students are expected to display responsible behavior by keeping track of their room key and University ID card (which is needed to enter the residence and dining halls). **Students will be charged \$150 for an unreturned key and \$25 for an unreturned building access fob.**

### **Authorized Areas within the Residence Hall**

Students should only enter designated resident hall areas — their assigned floor, the designated lounges, the laundry room, and the outside areas around the residence hall. Students should not “hang out” in the stairwells or on other floors of the residence hall.

### **Meal Attendance**

Overnight students will be eating breakfast and dinners at Brough Commons. Students are encouraged to attend every meal. Students will receive lanyards upon check-in that they must keep on them at all times to be admitted into the dining hall.

### **Dining Hall Schedule**

Fulbright Dining Hall opens for breakfast at 7 a.m. Campers should only go to breakfast apart from the group with their assigned counselor's permission.

### **Dining Hall Guidelines**

Students are expected to display respectful behavior toward all dining hall staff and adhere to all dining hall policies. All trash and trays should be cleared from the table and put in the appropriate place.

### **Scheduled Activities**

Evening activities are scheduled throughout the Design Camp week. Activities will include trips off campus, teambuilding exercises, movies, and more. This extracurricular programming is designed to provide fun opportunities for students to get to know each other, University of Arkansas campus, and the Fayetteville area.

### **Understanding the Consequences of Decisions**

Students are expected to understand and follow ALL program guidelines. It is an expectation and responsibility of the Design Camp staff to confront and address all inappropriate behavior that is observed or reported. Our goal is to educate students about the importance of being accountable for the decisions that they make and the behaviors that they display. Students are encouraged to think about the choices they have in any given situation and to make informed thoughtful decisions. For every action, there is a consequence. Students should be prepared to accept and learn from the consequences of their decisions.

### **Supervision**

A team of faculty, design coaches, and overnight counselors will supervise planned activities and serve as guides and resources during Design Camp. Students are expected to respect these leaders, and to follow their example and instruction.

### **Residence Hall Rules and Regulations**

- You are responsible for all items you bring. The University of Arkansas is not responsible for lost or damaged personal property.
- Your room should be kept neat and clean.
- You are not to be on other floors of the hall.
- You are to be on your designated floor by 10 p.m.
- You are to stay within the designated areas within the residence hall.
- Outdoor games are not allowed in the building (ball throwing, Frisbees, etc.).
- You may not place food delivery orders after 10 p.m. Food **MUST** be picked up in the lobby.
- The door of your room must be closed if music or television is being played.
- Candles and incense may not be burned at any time.

**Student Personal Items**

**BRING:**

*(Basic linens – sheets, pillow, blanket, towels, and washcloths – will be provided)*

- Toiletries (shampoo, deodorant, soap, toothbrush, toothpaste, razor, hygiene products, etc.)
- Shower shoes
- Swimsuit and towel
- Backpack
- Rain gear (umbrella, raincoat)
- Good walking shoes
- Sunscreen
- Pens, pencils, notebook and paper
- Snacks or change for vending machines
- Cell phone
- Students may also bring portable electronics that may be used ONLY during free time in the evenings
- Small amount of cash for incidental expenses (snacks on evening outings, late night snacks, spending money for books and souvenirs)

**WHAT TO LEAVE AT HOME**

- Cooking appliances/hot plates
- Bicycles or skates
- Incense/candles
- Food that needs refrigeration
- Skateboards
- Fireworks

Participants are responsible for all items they bring to campus. It is suggested that valuable items remain at home. **The University is not responsible for any lost, stolen, or damaged items.**
